#### Statistics

#### Google Analytics (Google)

Google Analytics is a web analysis service provided by Google, Inc. ("Google") which uses cookies to collect the User's Personal Data which is transmitted to and deposited on the Google servers in the United States. Google uses this information in order to track and examine your use of the website, compile reports on the website activities for the website operators and provide other services relating to the website activities and Internet use. Google does not associate the user's IP address with another data possessed by Google. If you do not allow the use of cookies by selecting the appropriate setting on your browser, this may prevent use of all the functions on this website.

#### Rights of those concerned

#### **Personal Data**

Any information relating to a physical person, legal entity, institution or association that has been or can be identified, also indirectly, through reference to any other information, including navigation data.

#### **Navigation Data**

Data collected automatically from the site, amongst which: IP addresses or domain names of the computers used by the users who connect to the site, URI (Uniform Resource Identifier) addresses, the time of the request, the method used to make the request to the server, the size of the file obtained in response, the numeric code indicating the type of answer from the server (successful, error, etc.), the country of origin, the characteristics of the browser and operating system used by the visitor, various time statistics concerning the visit (for example the time spent on each page) and details relating to the itinerary followed in the site with particular reference to the sequence of pages consulted and other parameters relating to the user's operating system and computing environment.
